

## **POLICY STATEMENT**

We at *Lisburn BMX Club* are committed to good practice which protects children from harm. Staff and volunteers accept and recognize their responsibility to provide an environment which promotes the safety of the child at all times. To achieve this we will:

- Develop an awareness of the issues which may lead to children being harmed.
- Create an open environment by identifying a 'Designated person' to whom the children can turn to if they need to talk.
- Adopt child centred and democratic coaching styles.
- Adopt Safeguarding guidelines through Codes of Conduct for members and all adults working at the club. Adult workers include coaches, parents and volunteers.
- Ensure careful recruitment, selection and management procedures. These
  procedures will include regular support and supervision is provided to
  staff/volunteers.
- Ensure complaints, grievance and disciplinary procedures are included in our constitution.
- Share information about concerns with children and parents and others who need to know
- Provide information as required to the management committee.
- Ensure good and safe working/playing practices.
- Be involved in training made available through the various agencies and strengthen links with these agencies.
- Keep Safeguarding policies under regular review (every three years minimum).
- Have procedures relating specifically to bullying, away trips, transport and use of photography.
- Have an induction document available for parents, coaches and children clearly outlining their rights and responsibilities.

# **Cycling Ireland Club Child Safeguarding Statement**

#### Section 1 – Club Information

<u>Club Name: Lisburn BMX Club</u> is affiliated to Cycling Ireland. Cycling Ireland is the National Governing Body for the sport of cycling on the island of Ireland. Cycling Ireland and its affiliated clubs provide various sporting activities and opportunities for children and young people through participation in clubs, regional/provincial events and through to our national teams. Organised events involve the provision of National championships and camps that in some instances require attendance at weekend events and overnight trips for clubs and their members both Nationally and Internationally. Cycling Ireland is a voluntary led organisation that provides its members with opportunities to participate in the sport of cycling through, Leisure/Sportive, Road, Para-cycling, Track, BMX, and Off Road disciplines, across all age grades including Junior Youth and Adults

### Section 2 - Principles to safeguard children from harm

<u>Lisburn BMX Club</u> is committed to safeguarding children by working under the guidance of our Safeguarding Policies. Our staff, both volunteers and employed, working with our young people, throughout the organisation, seek to create a safe environment for young people to grow and develop within sport. The following set of principles should be adhered to:

- **Importance of childhood** The importance of childhood should be understood and valued by everyone involved in sport.
- **Needs of the child** All children's sport experiences should be guided by what is best for children. This means that adults should have a basic understanding of the emotional, physical and personal needs of young people.
- Integrity in relationships Adults interacting with children in sport are in a position of trust and influence.

  They should always ensure that children are treated with integrity and respect, and the self-esteem of young people is enhanced.
- Fair Play All children's sport should be conducted in an atmosphere of fair play. The principles of fair play should always be emphasised, and organisers should give clear guidelines regarding acceptable standards of behaviour.
- Quality atmosphere & ethos Children's sport should be conducted in a safe, positive and encouraging atmosphere.
- **Competition** Competition is an essential element of sport and should be encouraged in an age appropriate manner. A child centred ethos will help to ensure that competition and specialisation are kept in their appropriate place.
- **Equality** All children should be valued and treated in an equitable and fair manner regardless of ability, age, gender, religion, social and ethnic background or political persuasion.

### Section 4 – Procedures

Our Child Safeguarding Statement has been prepared in accordance with the legislative requirements contained in the Children First Act 2015, Children's First: National Guidance for the Protection and Welfare of Children (2017), the Children (Northern Ireland) Order 1995, Tusla's Child Safeguarding: A Guide for Policy, Procedure and Practice. In addition to our Risk Assessment document described above, there are further procedures that support our intention to safeguard children while they are availing of our activities. For cycling clubs outside the jurisdiction of ROI, Cycling Ireland require NI clubs to adopt the Child Safeguarding Statement and Risk Assessment as part of best safeguarding practice.

**Cycling Ireland** has the following procedures in place as part of our Safeguarding Policies:

- Procedures for the management of allegations of abuse or misconduct by staff or volunteers against a child availing of our activities.
- Procedures for the safe recruitment of staff and volunteers to work with children in our activities.
- Procedures for access to child safeguarding training and information, including the identification of the occurrence of harm.
- Procedure for reporting of child protection or welfare concerns to Statutory Authorities.
- Procedure for maintaining a list of the persons (if any) in the relevant service who are mandated persons.
- Procedure for appointing a relevant person (Club Safeguarding Officer).

Please note that all procedures listed are available on request.

We recognise that implementation is an ongoing process. <u>Lisburn BMX Club is</u> committed to the implementation of this Child Safeguarding Statement and the procedures that support our intention to keep children safe from harm while availing of our activities.
